Bumper Guards Repopped.

Dear Studebaker Truck enthusiasts: I have recently completed the lengthy process of reproducing the small vertical bumper guards for M5, M15, and early M16 Studebaker trucks. These high-quality parts were made in mirror-polished 304 stainless steel so that they do not need chrome plating but match the color of

original bumpers. Every detail is exactly as the originals and the fit is correct. Molds for making these parts were made using the original drawings and original bumper guards to assure authenticity. The price is less than the cost of replating old parts. See the attached PDF file for pictures and details.

I now have these available for immediate shipment. Let me know if you would like one or more pairs of these bumper guards at \$200 per pair. Shipping in the U.S. is \$6 per pair. Shipping to the UK via air parcel post is \$21.10 per pair. I also still have decal kits for restoring the M truck instrument and speedometer faces, as well as the odometer wheels. These are priced at \$15 for the complete set, including postage in the U.S.

In addition, I am offering exact reproductions of the 1940s Studebaker parts counter sign at \$400. See <http://www.studegarage.com/sign.htm> for details on these signs and pictures. As always, www.studegarage.com is the place to look for information about restoring your Studebaker M series truck. Old Tires? Check the Codes.

QUESTION. How can I decipher the code on the sales invoice to assure myself that the tires were manufactured recently?

ANSWER. U.S. DOT Tire Identification Number is on one side of every DOT approved tire. This begins with the letters "DOT" and indicates that the tire meets all federal standards. The next two numbers or letters are the plant code where it was manufactured, and the last four numbers represent the week and year the tire was built. For example, the numbers 3106 means the 31st week of 2006. The other numbers are marketing codes used at the manufacturer's discretion. This information is used to contact consumers if a tire defect requires a recall.

Avanti Opens New Facility.

2006 The Associated Press, Oct. 24, 2006, 12:08AM = Avanti Motor Corp Opens Cancun Factory

MEXICO CITY — Avanti Motor Corp, makers of a luxury, stylish coupe have opened up a new factory in the Mexican resort town of Cancun, the company announced.

In a news release Monday, the Atlanta-based company said the factory started operating last week and aims to produce 400 cars per year. Next to the factory, the company will open a museum of classic Avanti models, the release said.

Avanti cars, which are popular with collectors, were originally introduced by Studebaker a year before the automaker went out of business in 1963. The original Avanti design was by Raymond Loewy for Studebaker as a way to save the flagging firm

Avanti Motor Corp was founded in 1964 and has produced the cars in Ohio and Georgia.
